### **Facility Rules**



#### The Golden Rule is:

- All renters must reserve their ring time by contacting the training director at: <u>dir.obed.pdtc@gmail.com</u> or call 732-742-5127
- All renters must fill out and sign a release form and include it with payment.
  - o Rental forms are found in the box on the table in front of the Club Room.
  - o Completed forms with payment should be mailed to the Training Director.
  - Checks should be made out to PDTC
- Attendees should park in the back of the building in the dumpster area.
- Everyone must use the door to the right of the side-walk, straight up from the dumpster.
- Be sure to lock the door behind you and put the key back in the lock box.
- Please make sure that everyone picks up after their dog!
- Do not allow dogs to potty on, near or in the building. Clean up any accidents that may happen.
- If necessary, please walk your dog by the side of the parking lot near the dumpster where you will find two potty stations. There are clean-up supplies in the building.
- Dogs must be on a leash at all time.
- If you use any equipment, please return it to where you found it.
- If anyone or their dog is not feeling well or showing signs of illness, please stay home.
- Dogs recovering from kennel cough should not attend events for 2 weeks after their last cough.
